FIELD OF CO-OPERATION -

A) Both the institutions shall evolve a mutually acceptable schedule to develop programs hold seminars and exchange visits.

B) The said academic interactions and intellectual assimilation may include. Faculty / staff development and exchange:

- Exchange of students:
- Seminars, research, conferences and workshops:
- Collaborations in the sharing of academic data, scientific information, intellectual property, articles and publications:

EXCHANGE OF STUDENTS/TEACHERS:

- Reciprocal arrangements based on mutually acceptable terms shall be accomplished to give an impetus to collaborative research and joint projects. Teachers, researchers, guides, and students of both the institutions shall be encouraged to work in tandem in the laboratories, workshops, faculties and departments of both the institutions.
- Issues relating to travel, boarding, lodging, miscellaneous expenses shall be incorporated in this para and shall vary according to the rules, regulations and policies of every institution.

MISCELLANEOUS:

- The tenure of the MoU would be for five years.
- The details for the efficacious implementation of this Memorandum of Understanding shall be jointly worked out on mutually acceptable terms within the parameters of the policies, rules and regulations of both the institutions.
- The parties to this memorandum may, by mutual consent, add modify, amend, delete, review or revise any tem(s) and conditions(s) of this agreement.
- The intent and implementation of this memorandum is **SUBJECT** to the policies of the respective states (in case of international agreements) and the laws of the land.

The **MoU** shall remain in force for a period of five years from the date of its signature and seal, and may be terminated by either side by giving a six months notice to that effect in writing. However, notwithstanding the

notice of the intent to terminate the memorandum, all rights. Obligations and corresponding duties and subsisting therein shall be respected and mandated till the finalization and accomplishment thereof.

The parties to this **MOU** undertake to treat as **CONFIDENTIAL AND PRIVILEGED** information of the other institution, which is so classified in advance. The terms of confidentiality and mode of disclosure shall be as per mutually acceptable terms.

This **MOU** shall require the ratification of the competent academic/executive body of both the institutions.
